**OPENING DATE: Immediately** **CLOSING DATE: October 27<sup>th</sup> 2017** ENTRIES **MUST BE RECEIVED NO LATER THAN October 27<sup>th</sup>** or late fees will apply. Entries **must be in writing and accompanied by a check** to be scheduled. If your WRITTEN entry is not received by the closing date you may not be scheduled. Enter early to be assured of a place. If show is oversubscribed, entries will be scheduled according to post mark. If entries exceed available daylight on Saturday, some classes may take place on Sunday 5<sup>th</sup> November. **A current negative Coggins test must accompany your entry.** You will not be allowed on the showgrounds without it!

**ATTIRE:** Casual and tidy with hard soled shoes. Helmet required when mounted – **this includes Western riders.**

**SCHOOLING:** Available Friday from noon onwards. You are welcome to school earlier but be aware arenas may still be being watered/dragged. A grounds fee of \$25.00 will be assessed if not stabling.

**NON-SHOWING HORSE:** \$10.00

**DOGS:** If you must bring them, they must be of a pleasant nature and please ensure they are leashed.

**STABLING:** Overnight \$30.00 (per night)

**SHAVINGS:** \$9.00 per bag

**GROUND FEE:** \$25.00 (if not stabled)

**CAMPER SPACE:** \$15.00 per day

**CLASS FEES:** \$30 per class. **LATE ENTRIES \$35/CLASS IF THERE IS ROOM IN SCHEDULE**

**PRIZES:** Ribbons awarded for 1st through 6th place

**LEVELS:** Introductory through Grand Prix
